



To help reduce the costs of education for families who cannot afford it, Monroe County Christian School offers financial aid through a Scholarship Fund. We believe the cost of tuition should not be a deterrent to families who wish to give their children a quality, Christ-centered education. To be eligible, all candidates must demonstrate financial need. A private education is a sacrifice for nearly every family.

We ask that families only apply when there is a true need so that the limited funds can be provided to those who cannot attend any other way. Families requesting aid cannot have outstanding tuition payments, upon receipt of a new scholarship.

The amount of financial aid varies each year based on the amount of money available in the fund. Applications must be submitted prior to the beginning of the school year. Any information supplied that is pertinent to a family's financial application is kept in strictest confidence and is viewed only by those responsible for making an award determination. The board recognizes that this is extremely sensitive information.
